NOTIFICATION**Admission for B.Com. 3rd & 5th Semester Students, 2026**

This is hereby informed to all concerned students of the **Gauhati Commerce College (A) only** that the Admission Process for **B.Com. 3rd & 5th Semester (FYUGP)** for the Academic Session 2026-27 shall commence from 27/08/2026 - 31/08/2026 as per the following schedule-

All eligible students are directed to complete their admission process within the stipulated period and submit the required documents and fees, as applicable, in accordance with the guidelines of the College/University.

Eligibility for Fee Waiver under the Prayagn Bharati Fee Waiver Scheme

Students seeking continuing admission in the 3rd /5th Semester and intending to avail the Fee Waiver benefit must fulfil the following conditions as prescribed by the Higher Education Department, Government of Assam:

1. The student's **parental annual income must be less than ₹4.00 lakh from all sources.**
2. The student must be a **permanent resident of Assam and possess valid Assam domicile.**
3. The student must **have at least 70% attendance** during the last academic year.
4. The student must have **no arrears/backlogs in the previous academic year.**
5. The student must have **enrolled for the final examinations of the previous academic year.**
6. The student must submit the prescribed **documents relating to income, domicile/residential status and Aadhaar**, as applicable.
7. **Ration Card issued by the competent authority of Assam shall be treated as the primary proof of income.** In the absence of a Ration Card, an income certificate issued by the concerned Revenue Circle Officer shall be accepted.
8. Students whose parents are employed under the State/Central Government, Semi-Government organisations or Government undertakings are generally not eligible. However, students whose parent(s) are employed as **Grade-IV/MTS** may be considered eligible subject to fulfilment of all other prescribed conditions.

Students who do not **fulfill the prescribed eligibility conditions** for fee waiver shall have to pay the applicable **admission fees of Rs. 6750/- as per the Govt. norms.**

Students having arrears/backlogs in the previous academic year(s) shall pay 50% (Fifty percent) of the applicable fee of Rs. 6750/-

All students are therefore advised to complete their admission within the prescribed period and ensure submission of all necessary documents.

For further details regarding the admission procedure, fee structure, fee waiver eligibility and **required documents**, students may contact the **Office of the Principal, Gauhati Commerce College (A)** during office hours.

All are requested to take note of the same and act accordingly.
